## PNWFM Meeting Minutes

October 20, 2019

President, Toby Seim, opened the meeting with 28 members present. Minutes from the May meeting were approved as printed in the newsletter. Bruce Kelley gave the treasurer's report. Our current balance is \$25,137. This does not include 2019 symposium expenses or earnings. Bruce reported that a check for \$15 from Canada was not processed because the bank app would not recognize the Canadian check. It was discussed that we may need to ask our Canadian members to use credit cards instead of checks. The silent and live auctions brought in approximately \$2700.

Old Business: Gary Hinderman, Vice President, reported that there are 6 cases in storage with varying repairs needed. He reported that repairs needed include a broken fan, fixtures, and others that are unknown. Bruce reported that he knows where to order parts from. A decision was not made as to when the repairs would occur but that they need to occur before our next symposium.

New Business: A report was given on the display at Whatcom Museum in Bellingham. Words used to describe the display included "world class" and "superb." Toby reported that the display includes informational panels, monitors playing videos, and world class mineral specimens. Toby also reported that the museum is doing an excellent job of promoting the display. Our chapter name is prominent in the display which is great for our own visibility. All members are encouraged to make the trip to Bellingham before February 2, 2020, when the display will be taken down. On November 3<sup>rd</sup>, Randy Becker will be giving a presentation at the museum. MSP to have Toby explore hiring a videographer to capture the display. It was suggested that Toby reach out to Brian Szobodo as a possible videographer. We would then have a showing of the video on Friday evening at next year's symposium.

Julian Gray proposed that all or most of the display be moved to the Rice Museum continuing as an "on loan" display for another 6 months to a year. Julian and Toby will reach out to those loaning specimens for the display to see if this is a possibility. If this doesn't work out, Julian would like for PNWFM to put a display in at the museum, and to continue collaborating with the museum providing displays.

Theme for 2020 symposium was discussed and voted on. Suggestions included: Mineral Photography/Photographers, Minerals of Madagascar, Colors in Minerals, Mineral Aesthetics, and Crystal Habits. Theme for the 2020 symposium will be "how colors and crystallography contribute to the aesthetics of minerals."

A discussion about capturing the symposium presentations by using a new technology that Brian Szobodo has created that includes a "device" that would capture the power point presentation and the audio was discussed. Julian will contact Brian to learn more about his new technology.

We still need to provide printed registration forms for members who don't want to use a credit card.

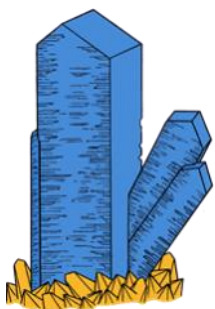
It was suggested that the times for open bar, dinner, and chapter meeting be included on the schedule. It was also suggested that information about the contests be sent out sooner.
