Harvey has spent a lifetime seeking out new mineral locations and bringing fine specimens to the marketplace for the enjoyment of our members and all mineral collectors. Friends of Mineralogy and the entire earth science community have greatly benefited from his dedication to the profession and the hobby.

A Tribute to Joe Nagel

Society of Mineral Museum Professionals, Vol. 5, #1 -- In 1997 (the Rice Museum) was essentially a brand new museum, in a residential facility, with an extraordinary mineral collection gathered over a period of 49 years by Richard and Helen Rice who, as collectors, had curated the collection for their personal pleasure and to share with others on a personal level. It was now my responsibility, with only a collector's experience, to curate this collection and make it available to students, professionals, hobbyists and the general public in a meaningful way. We did have a hand written log of the specimens but it needed updating and not a specimen had a label. Joe spent time, energy, and expertise directing me in the most efficient way to computerize the collection catalog and prepare the collection for labeling and appraisal. In the process he filled in much locality information that was not included on our specimen records and made valuable recommendations for aesthetic changes in our display. In one week, Joe and I had 3,500 specimens cataloged and labeled, ready for the appraiser. With the help of the computerized catalog, the appraisal was completed within three days with a valuation printout ready for estate lawyers, IRS and our insurance company. On top of all this, he was always just a phone call away to answer my many questions. I will always be grateful. He gave us the jump start to go from "a private collection" to a "professional museum."

- While on a trip through Texas, Don Guthrie of Seattle, WA, experienced a stroke. Lorna has gotten Don transferred back to Seattle where he is recovering at a health care facility. Short visits from friends would be appreciated.
- Rusty Etwiler, Secretary, had an abscessed tooth with swelling that threatened to close off her breathing. That put her in the hospital for over a week of intravenous antibiotics followed by

several more weeks of medication at home. Tooth is gone, swelling is down, life is returning to normal.

I wish all our members a speedy recovery and a return to normal activities.

I was fortunate to be able to attend the annual show in Tucson this winter. While there I attended the National FM board meeting, the FM Symposium, and the FM general membership meeting. I saw several FM members that were also able to attend, although I was not able to catch up to all of them on the show floor. At the board meeting we reviewed the priority list from the previous year, the progress that had been made and reprioritized the list for this year's goals. National FM is truly trying to help the chapters and making some progress. The symposium had some wonderful talks about collecting activities in Africa.

One of the things noted at the meeting was the significant drop in membership for the Pacific Northwest Chapter. We believe that many of our members intended to renew their membership at the symposium, but September 11 events combined to keep them from attending. We hope that with this newsletter you will be reminded and take the time to send in your dues.

“Rainbow of Minerals” 2001 Symposium Summary

The 27th Annual Pacific Northwest Friends of Mineralogy Symposium was held at the Red Lion Hotel, in Kelso/Longview, Washington, September 28 through 30, 2001. It was truly a “Rainbow of Minerals,” and enjoyed by 90 registrants. The Fluorescent Mineral Society joined with us this year and provided many of the very fine colorful exhibits. There were a total of twenty-six displays. We thank the Mt. Baker Club for again loaning us display cases.

There were four dealers on the main floor: Harvey Gordon Minerals, Lehigh Minerals, The Aesthetics Underground and Oxcart Minerals. Just off the main floor in the North Wing of the hotel there were 15 Satellite Dealers. We thank all of them for their part in making this a very successful symposium.

Presentations began Saturday morning when Master of Ceremonies, Dave Waisman, welcomed all symposium participants and introduced Don Newsome, who opened the Saturday morning program with a “live display” of fluorescent minerals and his talk “Fluorescent Minerals – Simple to Sublime.” Jesse Fisher, the second featured speaker, presented on two topics. His first slide show was of “Recent Work at the Rogerly Mine, Weardale, England”, followed by a slide program featuring the “Gem and Rare Element Pegmatites of Southern California.” Sunday morning, Sharleen Harvey showed slides of Arizona’s “Purple Passion Mine – Fuzzy Wulfenites and 5-Color Fluorescent Specimens,” and Lanny Ream brought us up to date on “What’s New in the Northwest” focusing on the zeolite locality at Challis, Idaho.

The annual and lively specimen auction, spearheaded by Bob Smith was held during the Saturday night banquet and netted \$1,148. The proceeds were used to help defray symposium expenses. Silent auctions were held throughout the weekend and added an additional \$165 to the PNWFM coffers. All specimens were donated by dealers, members and friends.

Rudy Tschernich and Lorna Goebel hosted the micromount booth on the main floor. Bob Meyer organized the challenging contests and awarded two \$25 prizes at the Saturday morning meeting.

The Noble Witt award was presented this year to Harvey Gordon for his long time support of the PNWFM Chapter and his many contributions towards the collection and preservation of mineralogical specimens.

Everyone enjoyed the interesting programs, displays and specimen shopping with a great group of dealers. We especially enjoyed visiting with friends and sharing collecting tales.

FM National Board of Directors Meeting

TUCSON – February, 2002, Friends of Mineralogy National Board of Directors Meeting. PNWFM members Bill Dameron and Sharleen Harvey were elected as Vice President and Director, respectively. President Jim Etwiler attended the meeting and reported on PNWFM 2001 activities and plans for upcoming 2002 meetings and programs. He announced that the next meeting will be held in Port Townsend, Washington, in conjunction with the 2002 NFMS and AFMS Gem and

Mineral Extravaganza July 18-21. The annual Washington Pass Cleanup is tentatively scheduled for the second weekend in August, and the 2002 Symposium will be held at the Kelso/Longview Red Lion September 27-29. PNWFM Chapter members will be encouraged to place exhibits at the AFMS show on behalf of Friends of Mineralogy to introduce the organization to potential new members. The Werner-Lieber Mineral Photo Contest is available for entrants again this year. Information and applications will be available at the September Symposium.

Pacific Northwest Chapter Friends of Mineralogy Board Meeting -- April 6, 2002

In attendance at the Board meeting were Aaron Wieting, Vice President, Bill Dameron, Treasurer, and Sharleen Harvey, Director. Jim Etwiler, President, and Rusty Etwiler, Secretary, were unable to attend. Also in attendance were Diana Dameron, who kindly hosted the meeting with her husband, Bill, and Jade Wieting, editor of the newsletter.

Acting on behalf of the president, Aaron called the meeting to order. As the secretary was not in attendance, minutes from the last meeting were not read. Bill provided the treasurer's report, which included an update on the organization's funds — currently \$8,941.11. Bill sent dues to the national Friends of Mineralogy for all members who have paid for 2002. However, he mentioned that many individuals are past due, which he asked to have addressed as an item of new business.

Old business items discussed briefly and tabled until the next meeting were: the issues of an insurance plan for field trips, and owner/director insurance.

The first item of new business was the Symposium. First, the topic for the symposium was confirmed. Both Bill Dameron and John Cornish confirmed speakers who will be talking about inclusions. Therefore, the decision was made to title the symposium, "Inclusions: The Inside Story". Security was discussed in detail, based upon breaches in security at the 2001 symposium. Between 10 p.m. and 8 a.m., both Friday and Saturday nights, a member will be on the floor. Additional measures will be taken to address security during dealer and exhibitor set-up and break-down.

Sharleen passed out a tentative budget for the symposium, which stands at an estimated expense total of \$7,040.00. This includes an increase in the registration fees from \$38 to \$45. Sharleen explained that costs have gone up, though our fees have stayed constant for many years. Bill moved that the fees for the symposium be raised to \$45. Sharleen seconded the motion. It passed unanimously. Bill moved to approve the full budget for the 2002 Symposium.

Other agenda items discussed included: the newsletter — Jade Wieting volunteered to put together the April newsletter; field trips — Aaron will call John Cornish to confirm that he will take this on and to confirm the date as the second weekend in August; membership; the Noble Witt Award for 2002 and the call for nominees; a local chapter website — topic was discussed and tabled; data management — Aaron and Bill will be working on building in consistencies to make it easier to pass on data to future officers; and communicating with the National Friends of Mineralogy.

Items of new business discussed included: information confirming that the NW chapter is still currently registered as a non-profit organization in Oregon; and the date for the next meeting, which will be held as part of the meeting being held in Port Townsend.

The meeting was adjourned.
