Dear members,

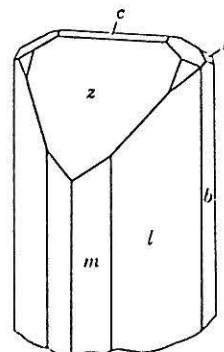
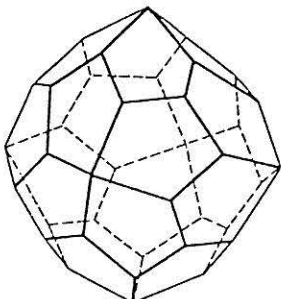

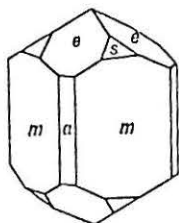
Treasurer's Report

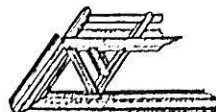
Minutes of Jan. 21, 1990 Meeting

The meeting, originally scheduled for the first week of February, was moved to January 21st so that members could attend the Tucson Gem and Mineral show. The meeting was convened at 10 am at the Clark county PUD building in Vancouver, Washington.

Becky Harris, President, opened the meeting. After presentation of the Treasurers report by Cheryl Stewart, a progress report was given by Mike Groben on the ROCKS AND MINERALS issue devoted to Washington State. The idea was born through discussions between Mike Groben and Marie Huizing. During the FM symposium in September, potential authors met with Mike and organized a committee to proceed with the project as a FM undertaking. The Committee will try to raise \$5,000 to \$7,000 through donations to make the Washington issue 100% color.

Mary Foster discussed plans for the 1990 Seattle Show. By April, Mary needs to know how many cases will be placed in the Seattle Regional Show by FM members, she is also in need of volunteers to help in the hospitality room. Lastly, if anyone has a nice stilbite crystal group from the south Fork of the Toutle to donate or loan to the Washington State Mineral Council, please call Mary Foster now.

There was a lot of discussion about the bad image that crystal collectors are receiving. A relatively recent "expose" of destruction at Hanson Creek appeared in the Seattle P.I. The U.S. Forest Service was forced to gate the upper road as collectors digging for amethyst had undermined the road. I checked the gate in December and someone had shot lock off. It was pointed out that unauthorized blasting had taken place at Walker Valley. One member stated that areas at Washington Pass have been trashed by collectors; and on it goes.... Steve Edmondson made a very good point: we have to do a better job of policing our own activities, those of commercial collectors, and be proactive in promoting responsible collecting practices. Thus, the idea of late summer collecting/clean-up field trip to Washington pass was born. I think it is a great idea. We can coordinate it with the U.S. Forest Service and in the process develop some good rapport.

Then we turned to the subject of the fall Pacific Northwest chapter fall symposium. First, we discussed the content and after some debate on whether to just go after some well known speakers on various subjects or to pick a theme, the consensus was to choose METALLIC MINERALS.

It was discovered that the Executive Inn had cancelled our regular dates and rescheduled us for a later weekend. Mike Groben pointed out that he will not be able to get key speakers for the symposium with the new dates. At that point, the symposium committee had no choice but to search for a new location so that we can have our symposium September 28th - 30th.

We made some tentative committee assignments. Mike groben will seek out noted speakers while at the Tucson Gem and Mineral show. He will also, with Ed Godsey, arrange for exhibitors and cases. Mike also volunteered to get the dealers. Dave todd will provide security. Cheryl Stewart and Lorna Gobel will do hospitality. We will try to get John Lindel to do the advertising or pre symposium publicity. Carl Harris will help with the picking up and return of the cases. Ray Lasmanis and Cheryl Stewart will

locate a home for the Symposium. The auction committee would hopefully be Bob Smith - again, Bob will need good material to hold a successful auction, no Junk, PLEASE!

There was a lot of discussion and even controversy about the two competitions that are part of our symposium. It was decided that there would not be a self collected competition in 1990 due to the poor showing last year. As for the slide competition, everyone thought we should continue to have it in 1990 but with a clear understanding of what the rules are for judging. It was suggested that the secretary publish the rules in the summer newsletter.

On a new subject, Dave Todd moved and Steve Edmondsom seconded the motion that \$250.00 be advanced by FM to print FM t-shirts for sale at the symposium. The motion was approved.

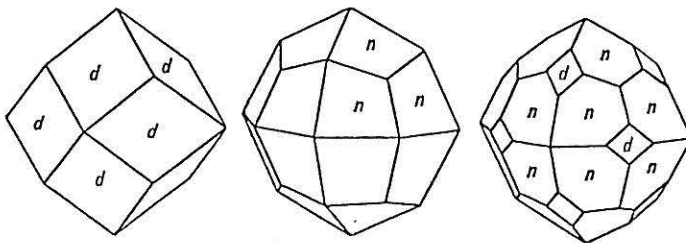
Finally the meeting was closed out with Three challenges by president Harris to the membership:

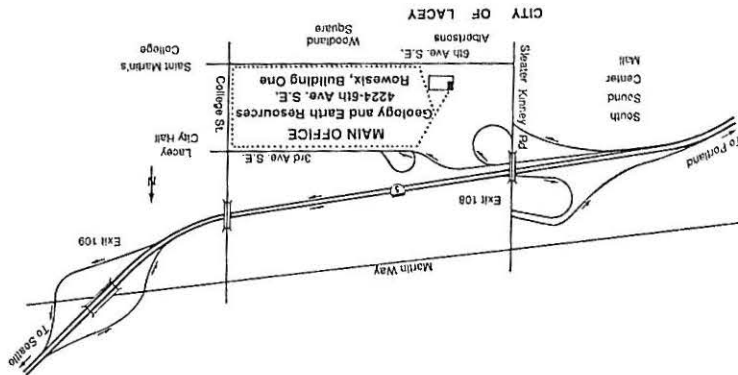
- 1) Assure that Northwest minerals are preserved in our National Museum - the Smithsonian. Ed Godsey and Rudy Tschernich point out that the Smithsonian lacks 20 years of recent specimen discoveries from the Northwest.
- 2) Support a drive to establish a quality mineral museum in the Northwest - the Burke Museum in Seattle and the NW Museum of Natural History in Portland were mentioned.
- 3) Need to organize a chapter educational outreach program to schools and to get younger members into the organization. This is something individuals can do.

In closing, we welcomed a new member, William (Bill) Leech of Salem Oregon. He, in fact, is very active in providing talks to area schools. Welcome, Bill.
