Auction Specimens

Many of us have had the enjoyable experience of participating in our symposium auctions. It's a lot of fun to bid on a piece you've just got to have, particularly when others are just as determined to have that piece themselves. Additionally, the auction raises money, which helps to cover symposium expenses. A successful auction is usually the difference between losing money on the symposium and breaking even.

To generate excitement for the auction, we encourage you to make your donations to the auction early, by bringing specimens, books, etc. to the meetings. We will then describe the donations in the newsletter.

Another of our members graciously answered my request for auction pieces at the June meeting. In order to create some excitement for the symposium, and for the auction (which is a key part of our being able to hold the symposia), a description of the pieces follows:

FM auction specimen #103. Vanadinite with minor Calcite—Pure Potential Claim, La Paz Co., Arizona. This specimen consists of a piece of coarsely crystalline brownish-grey Calcite, 10.5x7.5x4.5 cm in size, that is about three-quarters covered, on the 10.5x7.5 cm surface, by lustrous, sparkly red Vanadinite crystals of up to 4 mm in size, but averaging 1-2 mm. There are some tiny white bladed Calcite crystals associated at one end of the piece. Collected on May 16, 1998, by John Lindell. John Lindell collection label.

FM auction #104. Mineral Deposits, fourth edition by Waldemar Lindgren (1933). A classic book, in fair shape considering its age. Ex: Rudy Tschernich and John Lindell collections (signed).

Utah 98

On June 22, 13 people met at the Wendover, NV Information Center. Wes and Deb Gannaway, Bob and Sue Campbell, Dick and Janine Baird, Sharleen and Bill Harvey, Don and Lorna Guthrie, John and Maxine Dagenais, and Gary Hinderman. We proceeded to Gold Hill, Utah, and after setting up camp, everyone went up the hill and collected at various areas of the mine. Everyone seemed to get plenty of specimens and there was a scramble to find Japan Law Twins at the quartz outcrop. Several people did well on the Red Dump and found some good crystals of cupro-adamite. Nice showy crystals of conichalcite, talmessite, austinite, adamite, olivenite, and chalcantite, among others, were collected.

On June 23, we left Gold Hill and toured some of the back country, visiting such places as Trout Creek and Partoun before arriving at Topaz Mt. That evening we collected at the famous knoll. We also met Lanny Ream here.

On June 24, everyone went out to collect topaz. Most of us broke rock on the hillside, while Sharleen and Bill screened along the old creek and road. Everyone collected topaz, and Gary found a nice topaz crystal with a 'belt' of micro bixbyite crystals. Later that evening, after a potluck dinner, some of us went up to another outcrop and collected pseudobrookite and hematite. During the day, Scott Blair showed up to look for topaz. He later left for Gold Hill.

On the 25th, we all drove over to Eureka, Utah, and set up camp at the old Silver City townsite. We then met the president and the mine manager of the Grand Central Silver Mines at the Mammoth Mine in the town of Mammoth. The mine manager, Darby Sharp, escorted us through the mine area, both above and below ground, and his assistant escorted us to various collecting sites around the mine, where everyone collected specimens of azurite, malachite, chrysocolla, and brochantite, plus others. In the afternoon, Darby escorted us to the Centennial Eureka, another GCSM property, where we all broke boulders and collected a vast assortment of crystals, including malachite, hemmimorphite, azurite, pseudomalachite, acanthite, barite, galena, connellite, cornwallite, mimetite, and many others as yet to be identified when we get home.

June 26: we went back to the Mammoth Mine and collected from the dumps of the Mammoth and Sioux Ajax mines. In the afternoon we went to the North Star and Sunbeam mines. The North Star produced azurite, malachite, mixite, barite, and calcite, among others. the Sunbeam mine dump was covered with pyrite in quartz, and everyone got something. This was our last site at Eureka, and we sat around the campfire and enjoyed a nice evening and sunset.

On the 27, after saying good-bye to the Dagenais, the Bairds, and the Harveys, Lanny then led us to our next site, and we went back through Delta and south to Milford. Along the way we stopped at Sunstone Knoll and everyone picked up a few sunstones. We drove to the first of three localities near Milford. Our first locality was the Bawana Mine, the type locality for stringhamite, which we all collected thanks to Lanny showing us what to look for. Another mineral that a few of us collected was whelanite, a mineral that is still being studied. We also collected chrysocolla and brochantite. We then went to the Maria Mine and collected brochantite, clintonite, bornite, garnet, epidote, chrysocolla, rosasite, and calcite. At this time, the mine owner, Mr. McCauley, stopped by to see how we were doing. Lanny had received permission from Mr. McCauley to collect and camp on his properties. Our last stop of the day was the Hidden Treasure Mine which produced rosasite, chrysocolla, and brochantite. We

camped near the Old Hickory Mine and Lanny recounted stories of his earlier days as a geologist in the area.

June 28: we drove to the Okay Mine and collected some really nice azurite specimens, along with malachite, chrysocolla, and barite, plus some nice pseudomorphs of malachite and chrysocolla. Our last stop was to a nearby knoll that produced pockets with epidote, chlorite, fluorite, and titanite.

At this point the mineral collecting portion of the trip was over, and we all went our separate ways. Deb and myself and Gary went to Bryce Canyon, the Guthries camped south of Milford, and the Campbells went back to Topaz Mtn to collect garnets, and Lanny started for home (later in the trip we met with the Guthries and Campbells and Gary to collect trilobites in Wheeler Amphitheater). Everyone had a great time and got some nice things and I think that there will be plenty of time spent in enjoying the specimens and memories of this trip.

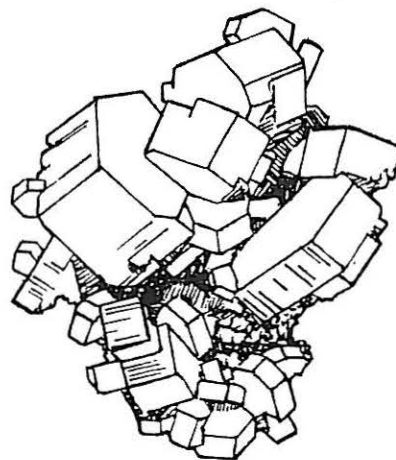
